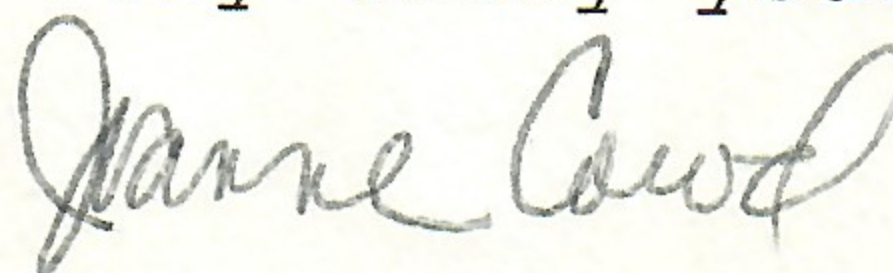

WARRANTY DEED WITH LIEN COVENANT

THIS INDENTURE, made the 19th day of March, 1997,

WITNESSETH that the Grantor, in consideration of ONE DOLLAR (\$1.00) lawful money of the United States, and other valuable consideration paid by the Grantee, does hereby grant and release unto the Grantee, its heirs or successors, and assigns forever,

SEE SCHEDULE "A" ATTACHED HERETO AND MADE A PART HEREOF...

Subject to all covenants, easements and restrictions of record, if any, affecting said premises.

Being and intending to convey part of the same premises conveyed to Oliver P. Stymus and Alberta M. Stymus (who died on March 26, 1983), his wife, by deed dated and recorded on March 3, 1967 in the Monroe County Clerk's Office in Liber 3799 of Deeds, page 199.

LOCATED ON THE EAST SIDE OF MIDDLE ROAD, COMMENCING AT A POINT IN THE CENTERLINE OF MIDDLE ROAD, SAID POINT BEING THE NORTHWEST CORNER OF THE MAPLEWOOD CEMETERY PROPERTY. THENCE 1. N 73 DEGREES E ALONG A LINE BEING THE NORTH LINE OF THE MAPLEWOOD CEMETERY PROPERTY A DISTANCE OF 145.01 FEET TO A POINT.

THENCE 2. S 56 DEGREES E ALONG THE NORTH LINE OF THE MAPLEWOOD CEMETERY PROPERTY A DISTANCE OF 71.55 FEET TO A POINT.

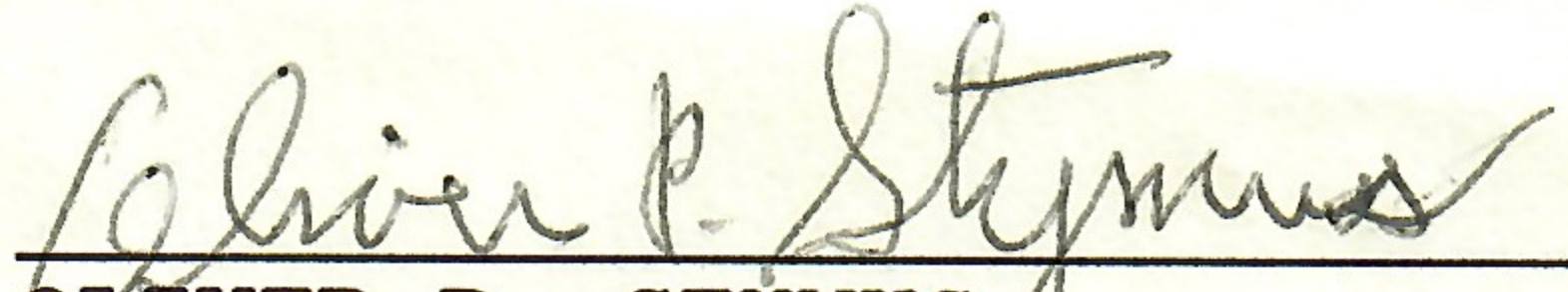

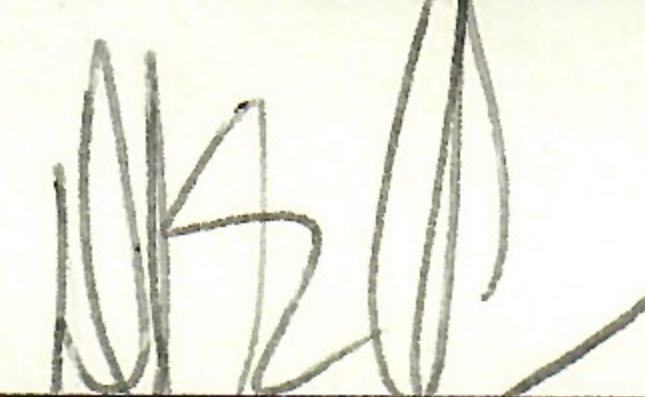
