Dear Cemeterian:

Enclosed is a copy of an Order of the New York State Cemetery Board.

Please be advised that no rate or charge may be increased, decreased or added without specific authorization by the New York State Cemetery Board. Both service charges and lot prices shall be posted in conformance with Section 1510(a) of the Not-for-Profit Corporation Law and shall be charged only at the authorized prices filed in the office of the Cemetery Board.

Prices for burial rights (graves, lots and mausoleum space) are not subject to Cemetery Board approval but must be filed with this office pursuant to Section 1513(b) of the Not-for-Profit Corporation Law. Sub-paragraph (2) of the above reference also requires that at the time a sale of burial rights, the purchaser shall receive a copy of the rules and regulations and the restrictions relating to the use of the plots and an outline of the obligations (charges for services) of the lot owner.

If not already included as part of the rate application, A COPY OF THE COMPLETE LISTING OF ALL THE CEMETERY SERVICE CHARGES MUST BE FILED WITH THE DIVISION OF CEMETERIES WITHIN 21 DAYS OF RECEIPT OF THIS LETTER. Please indicate your compliance with this request when you return the rate list to distinguish it from another rate application. One option would be to return a copy of this letter with your submission.

By application received January 24, 2025, Maple Wood Cemetery, Monroe County, Cemetery No. 28-018, requested permission to increase its charges for services.

The Cemetery Board has reviewed the finances and the operation of the cemetery corporation and has determined that the requested charges are fair and reasonable.

Therefore, pursuant to Section 1509(c) of the Not-for-Profit Corporation Law, the requested charges are approved as follows:

**An additional charge may be made for snow removal or penetration of frost based on the additional costs to the cemetery pursuant to Section 1509 (d) of the not-for-profit corporation law.

This board order does not include charges that are not new or being changed from what the Division previously approved.

Foundations for all upright monuments, by whomsoever installed, shall be no less than the width and length of the base of the monument and shall be poured in concrete to a depth no less than the full depth of the grave or its equivalent if rock conditions exist.

The approved rates and charges shall become effective five (5) days after the filing of this Order in the office of the Cemetery Board, except that the approved foundation rate and charge shall become effective thirty (30) days after such filing.
